Our Defensive Growth Strategy can shift between stocks, bonds or cash depending on our assessment of the risk-reward relationship of the stock market. Our Flexible Fixed Income Strategy adjusts the portfolio duration and credit quality based on our evaluation of the direction of interest rates and the credit risk environment.



The top 10% of funds in each category receive 5 stars, 22.5% receive 4 stars, 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.
