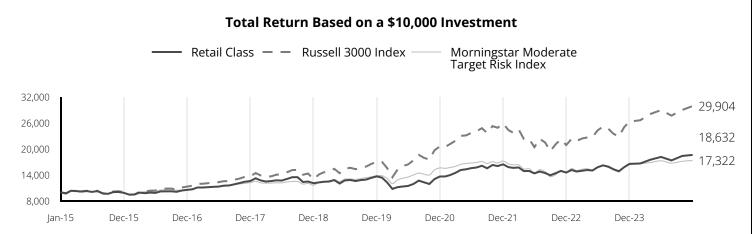
#### **Fund Overview**

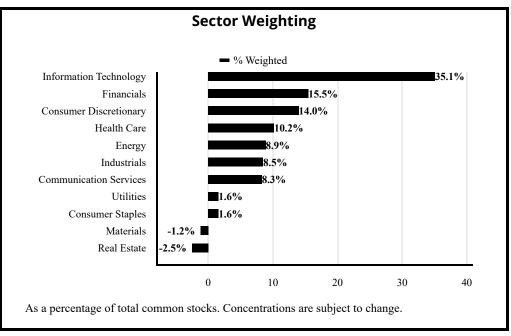

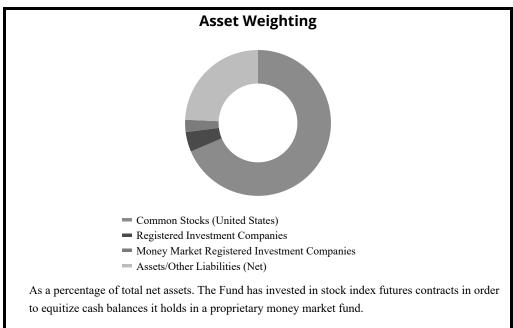
